Navigating the new Bizfile: Apply for new business entity name

Before starting a new business or making changes to an existing business entity, you must first register a business name in Bizfile. This e-service caters to both new and existing business entities as follows:

Upon approval, the registered business name will be reserved for **120 days**. If you do not complete your business registration or incorporation within this period, the reservation will expire, and the name will be released for anyone to register.

If you are applying for a business name for registering a new business entity and are not a Corporate Service Provider, you must intend to hold the following positions in the new business entity:

- Owner of a sole proprietorship or partnership
- Authorised Representative of a sole proprietorship or partnership if all owners are not locally resident.
- Director or Secretary of a local company
- Partner or individual Manager of a limited liability partnership
- General Partner or General Partner as a Nominee/Trustee of a limited partnership
- Partner under S18(3)(c) of the Accountants Act or Public Accountant Employee for Public Accounting Firm
- Director under S17(3)(d) of the Accountants Act or Public Accountant Employee for Public Accounting Corporation
- Partner under S18A(3)(e) of the Accountants Act or Public Accountant Employee for Accounting Limited Liability Partnership
