## Navigating the new Bizfile: Buying Business Profile

The Business Profile is an essential document containing key information about business entities registered with ACRA, including their Unique Entity Number (UEN), entity name, business activities, incorporation or registration date, and details of position holders, business owners, or partners.

You can search for registered business entities across all categories using Bizfile portal's new integrated Federated Search function.

Once you have located the business entities, you can purchase the Business Profile through Bizfile with or without logging in. You may proceed as a guest user for direct purchase. If you prefer to access additional account features and the ability to track your purchase history, you may log in with your Singpass or Corppass credentials <u>before</u> making the purchase.

## **Processing and verification of Business Profile**

After payment is completed, you will receive an email with download instructions within 15 minutes.

## Important Notes:

- 1) To access the <u>product download page</u> via the Bizfile link in the delivery email, you will need the unique product download code and your delivery email address.
- 2) Please download your Business Profile within 30 days, as the download links will expire after this period and cannot be extended.

Your Business Profile purchase includes two file formats: a PDF for viewing the document and an OA (OpenAttestation) file for verification purposes. To verify the authenticity of your Business Profile, you can either:

- scan the QR code on the PDF,
- click the verification URL provided in the document, or
- upload the OA file to the trustBar Portal ACRA's free verification service that allows you to check whether the document is issued by ACRA.
