### Navigating the new Bizfile: Clear Objection against Striking Off

The "Clear objection against striking off" eService allows individuals, corporate entities and Corporate Service Providers (CSP) that have previously filed objection against striking off applications, to clear the objection after the outstanding matters are resolved.

You can only file to clear an objection to striking off after the initial objection filed has been approved.

- For objections filed by individuals using Singpass, only the same individual who lodged the initial objection can clear it.
- For objections filed by corporate entities or CSPs, any authorised Corppass user within the entity can lodge the clearance.
