### Re-opening of ACRA Service Counters from 19 Jun 2020 - Safe Transition

In line with Phase 2 of Singapore's re-opening after the circuit breaker period, ACRA service counters at the Taxpayer and Business Service Centre at Revenue House will re-open and operate by appointment only from 19 Jun 2020. This is to safeguard the health and wellbeing of the public and our staff.

# ACRA's support for businesses and public accountants during COVID-19

ACRA has issued the following guidelines to help companies and public accountants comply with the financial reporting and auditing requirements during the COVID-19 situation:



The guidance assists directors in their review of financial statements during the COVID-19 situation, and highlights areas that may require close attention before directors approve the company's financial statements.





Audit Practice Bulletin No. 1 of 2020

The bulletin guides public accountants on complying with the requirements of auditing standards when performing audits of financial statements in the COVID-19 environment.



## Implementation of revised XBRL filing requirements deferred to 1 Jan 2021

ACRA has issued Practice Direction No. 2 of 2020 to guide companies on the revised requirements and the data elements in the filing of financial statements in eXtensible Business Reporting Language (XBRL) format. The revisions are part of our continual efforts to streamline filing requirements. To allow companies more transition time in view of the COVID-19 situation, the effective date for the revised XBRL filing requirements has been deferred as follows:

- Companies are required to apply the revised filing requirements and data elements from 1 January 2021
- Companies can opt to voluntarily apply the revised filing requirements and data elements from 16 May

ACRA has also launched an updated version of the BizFin<sup>x</sup> preparation tool to help companies to prepare, validate and upload their XBRL financial statements based on the revised filing requirements.
