Mr Ong Chong Tee (王宗智) Deputy Managing Director (Financial Supervision) Monetary Authority of Singapore *(until 31 March 2021)* 

Mr Ong Chong Tee is currently the Deputy Managing Director in charge of Financial Supervision at the Monetary Authority of Singapore (MAS).
